If an order does not arrive by the due date, we will lodge enquiries with the courier to ensure that delivery occurs as soon as possible.

We will not be held liable for any loss or damage resulting from late delivery. You acknowledge and agree that late delivery does not constitute a breach by us of our agreement and does not entitle you to cancel an order.

Please note that if an item has been lost in transit, we will not despatch a replacement item immediately. Replacement items will only be despatched at our discretion.

We will not accept liability for any loss or damage arising from items lost, stolen or damaged after delivery has taken place

#### 1.9 Returns and Exchanges

If you wish to return an item simply because you change your mind we will exchange or refund provided you return it within 14 days from the date of purchase, unworn and in its original condition with labels attached and with our original invoice. Sale items will only be exchanged not refunded provided you return it within 14 days from the date of purchase, unworn and in its original condition with the labels attached and with our original receipt.

Zinc Pty Ltd is not legally obligated to give refunds off the purchase price on items or exchange them simply because you have changed your mind about the purchase.

However, under our 'change of mind' policy, if you simply change your mind we do offer a refund, exchange of value equivalent to the purchase price for most items provided that:

- a) You return the item within 14 days from the date of purchase; and
- b) The item is unworn and in its original condition; and
- c) All original labels are attached to the item; and
- d) You provide the Tax Invoice as proof of purchase.

Our customers are entitled to a refund if the item is faulty, not of merchantable quality or not fit for its purpose. Our policy under these circumstances is:

You (the customer) are entitled to a refund for items you purchase if the item is:

- Faulty and the fault or defect was not pointed out to you before you purchased it or would not have been apparent to you when you inspected the goods before purchase; or
- b) Not 'of merchantable quality', meaning that it is not of the quality that you reasonably expected when you purchased it, bearing in mind the way the item was described to you before your purchase and also the price of the item; or
- c) Not fit for its purpose, meaning that the item does not do what you reasonably expected it would;

and you return the item within a reasonable time after purchase and provide proof of purchase. If you do not return the item within a reasonable time, you will not be entitled to a refund at the purchase price but you will be entitled to exchange the goods or have them repaired.

Zinc Pty Ltd reserves the right to ask you to demonstrate that you did not cause or create the fault in the item.

If you are entitled to a refund but you would prefer to exchange the item, we are happy to do this for you.

Should you wish to exchange the item for an alternative size or colour, please enclose with your goods a postage paid, self-addressed bag (Australian residents only).
